


**Division of State Lands** – Also one of the members brought up that NWMP indicated that the Division of State lands is having a meeting something about filling in holes in streams and to remind us that the DSL requires miners to send a <u>Recreational Placer Mining year-end report form</u> summarizing activity. Failure to report may result in cancellation of the approval. Oct 7 at 12 noon, Division of State lands in Salem.

**Safety – Bob Rasey –** If you are out on the claim, walking along the streets in your neighborhood or else where if you come across any glass jars/bottles that are capped with a milky oily looking substance in it DO NOT MOVE or TOUCH IT! It could be dangerous. These have been known to explode. Also as the dry season starts to end may think about moving from streams to tunnels/mines. Be extremely cautious. They can be unstable, rotting timbers, rocks falling, gases. Stay Out of abandoned mines or tunnels. Once again this time of the year wear hunters orange clothing when out in the woods mining or other activities.

Before the weather starts turning bad you should start preparing for winter. Check chains, and other safety equipment. Don't forget to winterize your mining equipment/motors some Stabil gas additive could prevent problems in the spring.


