Secretary's Report June 21, 2015

Milwaukie Grange Hall, 12015 SE 22nd Milwaukie, OR

Meeting called to order by President Dave Chiara at 1:32 pm

Pledge of Allegiance conducted.

Attendance:

41 attendees at the meeting

2 visiting guests were present

Meeting minutes:

A **Motion** was made and seconded to accept the Secretary's report as written and published in the newsletter.

The motion was approved by the Association members present.

Treasury report: Beverly Parker

The Treasury report was read by the Treasurer to the association.

A **Motion** was made, seconded, and approved to accept the Treasurer's report as written.

Correspondence:

The Association receives a monthly newsletter from Eastern Oregon Mining Association that is available for members to read.

President's Report:

Dave Chiara updated members on the group event to the club claims near Baker City, Oregon known as Tyroy claims. The date has been set back because we are waiting for the reclamation bond on the Notice of Operation as submitted to the Bureau of Land Management (BLM). Richard Ruth was thanked for his assistance with the Notice. Our Association was also assisted by Eastern Oregon Mining Association to follow BLM rules. The Notice may allow some excavation on the claim to find minerals. President, Dave reminded members that no one can use mechanical excavation until the final BLM approval and our association will be responsible to back fill and reclaim the disturbed area. A discussion followed on whether to use EOMA Bond assistance for a fee or to use our own Claim Fund for the Bond which is similar to an escrow account with BLM. Discussion followed about the time delay with EOMA and cost of the Bond. Bob Burns made a **Motion** to use our Claim Fund money for the BLM Bond. The Motion was seconded and passed.

Ken Burns and Jerry Johns discussed the events that are scheduled soon.

Ken Burns stated those who are going to the Tyroy event will need to sign the release form. Jerry reviewed the past June 16 event that was held at Daybreak Park near Battleground, WA. It has good access and our members had a nice picnic there. Another outing has been added at Daybreak Park for Aug. 8th. Members need the Gold & Fish Book (available online) and some copies will be at the July meeting.

Members were encouraged to go to the Rice Museum of Gems to see an outstanding mineral collection.

Safety:

Melinda Dorning read information on how to help yourself if you experience heart attack symptoms when you are alone. Strongly coughing may assist the heart beat similar to CPR compression techniques. Also, Jerry reminded members that ticks are present in Eastern Oregon and other areas. Here is a way to safely remove ticks. 1) Apply a small amount of

liquid soap on a cottonball, 2) Cover the tick with the soap/cottonball, 3) Blot it for a 15-20 seconds, 4) the tick will detach and stick to the cotton ball as you remove it. Also spray pants with bug spray and use dryer sheets to detract bugs.

Newsletter:

Bill Mutton asks members to send him ideas for new topics in the newsletter. The newsletter is available on the Association website. To have a copy mailed to you, there is a \$15.00 annual fee to cover printing and mailing costs

Library:

Joe Weber mentioned there are two new books in the Library: Gem Trails of Washington and Gem Trails of Oregon. Joe brings the library materials each month so members can check them out and return things the following month to make them available for others to enjoy. The library is free to members. Let Joe know if there is something you would like to have added to the library. Walt Richie displayed maps for members to review. Also the club safari style hats with neck flaps were suggested to protect from the hot sun.

Old Business:

Several members held a demonstration this month at the local Cabellas store. By volunteering they received a \$25 gift card from the store and free food. Our association also recognizes those who volunteer with special raffle prizes throughout the season. The Cabellas store asked us to return at a future date. It really pays to volunteer and support our group.

President, Dave explained more details from BLM. They restrict camping to only 14 days every 90 days. Code of Conduct: Dave Chiara reminded members to contact a Board member for any concerns.

New Business:

Ken Burns said our association was invited to a July 19 picnic and event at Daybreak Park with the Vancouver GPAA Chapter. Since this day falls on our regular meeting date, the members decided to decline. We would like to maintain a good relationship with the Vancouver Chapter as co-sponsor of the Gold Show.

Porta-Potties are reserved and \$410 paid for at the Tyroy claims in June. Discussion followed about whether this cost will be paid by participants or by the association funds. Bob Burns made a **Motion** that the association pay for the porta-potties. The motion was seconded and passed. Donations are suggested from those who use the porta-potties. Also it was suggested to bring water containers for drinking and washing; and bring a fire extinguisher.

Next discussion was the dates of the event at the claims. The backhoe will arrive on June 27 and major equipment will leave before mid-July. Some members may arrive on June 23, but large equipment will not be available. A potluck is planned during the event; bring food to share. Contact the President if you need more information.

Dave Chiara thanked the kitchen staff and those who donated cookies.
The meeting was adjourned at 3:48 pm after the raffle was held.

Article of the Month

Repeated from June 2015 (if you have something – please send in)

Remember it is always advisable to check with Park staff before you go digging anywhere on the Oregon coast. You should be careful not to be on private property and always clean up after yourself. Fill your holes and take what you bring. And if you want to help if you see someone else's trash take that will you when you leave. Leave it better than you found it.

Oregon Beach Placers:

Beach placers along the Oregon coast were richly productive for a time after their discovery in 1852 and have since yielded small amounts of gold and platinum annually. Renewed interest in then was caused by the industrial depression that followed 1929. A little placer gold may be found in almost any section of the beach, but the bulk of it is confined to certain stretches south of Coos Bay. Along the Oregon coast gold and platinum bearing deposits were discovered on the present beaches in 1852 and on tile ancient elevated beaches 18 or 20 years later. In places the deposits were rich, and for a time they were mined extensively. According to a popular report a production of several million dollars, chiefly in gold but with a minor content of platinum, was obtained. After the more profitable stretches had been worked over mining activity decreased, out no season has passed without some production. In 1930 and 1931 renewed interest in the deposits was stimulated by the fact that the value of gold had become relatively enhanced as the result of the depressed economic conditions throughout the country. For this reason a field examination was made in June 3, 1931 of parts of the coastal belt, chiefly between Coos Bay and the California line. Increases in the price of gold since the field work was done gives the deposits an added interest.

The generally mountainous Oregon coast is bordered in places by coastal plains that range from a quarter of a mile to 4 miles in width and are mostly less than 100 feet high. The plains are of two different geomorphic suites. 'One consists of lowlands composed of bay mouth bars or barrier beaches and the filled embayment's behind them; the other is a group of slightly elevated marine terraces. The different terraces are capped with Pleistocene marine sediments, the largest area of which is between Port Orford and Cape Arago and is related to an ancient shore line at an altitude of

170 feet. Beds formed offshore compose a terrace plain about South Slough that is somewhat lower, and there are remnants of beaches in some of the other terraces. The placer deposits are wave-concentrated layers in the beaches and offshore beds and are generally called black sands for the reason that they are composed largely of [magnetite](#), [chromite](#), and other heavy minerals, most of which are dark-colored. Commonly these layers contain small particles of gold and platinum, and in places the metallic particles are abundant enough to be extracted profitably. The gold and platinum that are recovered from the beach deposits occur as particles most of which range in size from that of a small pinhead to microscopic specks. A sample of platinum from the Pioneer mine consists mostly of rounded flat grains from 0.8 to 0.05 millimeter or about 0.03 to 0.002 inch in diameter and from 0.05 to 0.005 millimeter or less in thickness. These grains weigh from 0.55 to 0.01 milligram.

Although a few specks of gold or [platinum](#) can be found almost anywhere along the present and ancient beaches, the workable deposits so far discovered form only a part of the whole and, as a rule are confined to the beaches bordering the shores that have receded under wave attack. In those beaches that are retreating under wave attack the deposits are variable and inconstant, but certain beaches are likely to be richer or more often workable than others. In the shores that are now retreating the beach varies in extent and composition from time to time as the result of wave action caused by storms and tides. Thus a stretch that is barren on one day or in one season may be productive at other times. There are, however, certain stretches that have been richer and are more often workable than the rest. These are, in order from north to south, in the vicinity of Newport, Whisky Run, Cape Blanco, Port Orford, and the beaches near the mouth of Rogue River.

Owing to the transitory character of the foreshores of the present beach no definite estimate of reserves can be made, but it is concluded that deposits suitable for small scale operators will continue to form here and there along certain parts of the coast. Ordinarily these deposits may be expected, under the working conditions possible, to yield from a few cents to 2 pennyweight a day per man. In places the backshore contains noteworthy amounts of gold and platinum, but in the decade immediately preceding 1932 attempts to mine the deposits apparently met with no success, and no basis for an estimate of their value exists. The backshore of the present beach and the ancient beaches up to an altitude of about 170 feet have been the most productive. The pay streaks generally ranges from a few feet to 200 or 300 feet in width, is 3 or 4 feet thick in the middle, and tapers toward the edges. It consists

largely of alternating layers of black and gray sand with more or less cobbles, boulders, and drift wood and in the ancient beach, is mostly covered with a barren sand "overburden" 20 to 60 feet thick.

The immediate sources of the beach minerals, including gold and platinum, are the shores that are being cut back by the waves. Most of the gold-bearing beaches are south of Coos Bay, along the coast opposite the Klamath Mountain region, described by Diller, which contains several areas of gold-bearing lodes. The lodes of the interior were the ultimate sources of the gold from which it has been carried seaward at intervals since middle Tertiary time. In the past, as at present, the streams sorted the gold during its transportation, leaving the larger grains near the source and distributing progressively smaller and smaller particles downstream. As a result of stream sorting only the finer particles reached the coast. No definite source of the platinum has been found, but its distribution and its association with chromite suggests the abundant serpentinitous and other basic intrusives of the region. However, no relation of the platinum and chromite of the beaches to any particular rock mass could be made out.

Pay streaks have been worked in the ancient elevated beaches or related offshore beds in the terrace plains north of Port Orford, north of the Rogue River, around South Slough, and in a terrace 800 feet above sea level at the Peck mine, on the spur north of the Sixes River. On the terrace plain north of Port Orford the deposits were formed when the sea stood about 170 feet higher than now. At that level the shore was cut back along two stretches one of about 4 miles between the Sixes River and Denmark, the other of about 4 miles extending north of Cut Creek. Pay streaks that were concentrated by the waves along parts of their stretches are exposed in the Majden and Butler mines, north of the Sixes River, and in the Pioneer, Eagle, Fletcher & Myers, and Rose mines, north of Cut Creek.
