PRESIDENT'S BLOG October-November, 2020

>>>NO MEETING IN NOVEMBER<<<<

We are 9+ months into the Covid-19 pandemic, with no quick or easy answers in sight.

As President of PGPI, I have been making the decision regarding monthly chapter meetings; I have asked for ideas regarding alternatives to a full group meeting or a different location, etc. I have not heard from anyone in the chapter regarding a different location or meeting format. However, I have heard from several members that holding the current course of NOT having meetings is the best way to keep our members safe. I appreciate all sides to this decision insofar as some members may think we are being overly cautious. I really can't speak to that other than to say some people are getting incredibly sick and some people are dying. I don't have the answers as to who, how or why. With that being said, I think most prudent course is to NOT have monthly meetings for the time being. I know I would be devastated if one of our members got sick as a result of attending a meeting.

In any event, Clackamas County remains in Phase I - which provides the following conditions: Indoor meetings/activities are capped at 10 people with required social distancing. Cultural, Civic and Faith based groups can have up to 50 people, with required social distancing - I am not sure our group fits the definition of either "Cultural" or "Civic..."

This is frustrating because at this time of year we would normally have nominations and the election for some new officers and board members. In addition, we would be planning for our annual potluck, plus working on the 2021 GPAA Gold and Treasure Show. We would also be working to organize more outings, speakers and demonstrations for 2021. As it is – we will have to see how it goes.

Since we can't hold nominations and the election of some officer and board member positions now, Charlie Foster recommended that we extend everyone's term by one year. I am making a similar recommendation to the Board; my recommendation is that we extend everyone's term by one year or hold nominations and the election when meetings resume, whichever comes first. I am not sure if it requires a vote by chapter members or not – If it does, we will notify our members by e-mail.

Since none of us has been through something like this before, I am trying to do what I think is best and safest for the group. However, I remain open to any other thoughts or ideas - I don't want anyone to lose interest in the group because we aren't having meetings right now....

















PANNING DEMONSTRATION

Jim had four panning stations set up and also had his metal detector out to do some demonstrations. Luckily, everything was set up in Jim's barn, since it was pouring down rain most of the day!
